January 9, 2020

The Root River Soil and Water Conservation District Board of Supervisors met on January 9, 2020 at the Ag Service Center in Caledonia, Minnesota for its regular meeting.

## Agency Reports:

## Gary Larson, NRCS Board Conservationist Report

Larson shared conservation planning has been one of the focus areas this past month. Larson indicated that there are 22 RCPP EQIP applications and 28 EQIP applicants that were not funded last year that have opted to keep their application active to be considered again during the next funding period. He stated in addition to those applications there are approximately 20 new EQIP applications.

Motion carried.

- Larson stated a CRP sign-up is in process. To date there are ten continuous CRP sign-ups (at an average payment rate of \$149/acre) and 80 general CRP sign-ups (at an average payment rate of \$140/acre). The general CRP sign-up deadline date is February 28, 2020.
- Walter stated the Caledonia Field Office was the fifth highest in the state of MN for EQIP applications and funded applications in 2019.

## Dave Walter, SWCD District Manager Report

Walter reported he met with the county commissioners on January 7<sup>th</sup> and discussed the Local Capacity county match option to the Local Capacity grant. County commissioners approved appropriating \$14,400 to the SWCD for the Local Capacity Grant. Walter stated that he informed the commissioners that the appropriation would be used for BMPs. He also told our board supervisors that BWSR would be matching the funds that the county is appropriating.

### Program Reports:

- WCA Walter reported the final plat for the horse track is being reviewed.
- Bridge Creek Walter informed the board that we are entering the last year for this program. A waste storage facility will continue to be constructed in the spring. No other projects are scheduled at this time.
- **RCPP 1W1P** Walter stated there have not been any recent projects.
- Root River 1W1P Walter shared \$1.4 million is being allocated to the Root River 1W1P. Of the \$1.4 million the Root River SWCD will have \$125,000 for BMP projects and \$50,000 for Technical & Engineering. Crooked Creek Watershed will have \$380,000 for the Klinski project and \$55,000 for Technical & Engineering.
- Aquatic Invasive Species (AIS) Walter stated \$22,000 will be appropriated to the SWCD for 2020.
- MAWQCP A workshop is scheduled for January 14, 2020 at Good Times in Caledonia, MN.

## Watershed Updates:

**Crooked Creek** – Scanlan reported that the next meeting is scheduled for Friday, January 17<sup>th</sup>. He indicated that the results from ERI testing for the Klinski project were received today along with recommendations from the NRCS geologist. Scanlan stated that a new appropriation of Root River 1W1P funds has been earmarked.

Scanlan shared that he is working with Caledonia High School on maintenance options for a storm water pond. The possibility of goats to perform the maintenance was explored but there are concerns about the goats getting sick if they intake the storm water.

Bee & Duck Creek – No report.

Bear Creek - Larson stated clearance has been given to move forward with survey on the Anderson sinkhole site.

Winnebago - Walter stated there is a sinkhole on the Koch site that will need repair.

## Staff Reports:

## Bob Scanlan – Program & Staff Reports

- **Cooperative Weed Management Area (CWMA)** Scanlan shared that a funding application was submitted this fall and we are waiting to hear if we were accepted for the grant funding.
- **Cover Crop Demonstration Grant** Scanlan stated the SWCD has been awarded \$226,000. Since the approval he has submitted a work plan and it was approved. Scanlan reviewed the work plan with the supervisors and added that he is currently developing policies for cost share, equipment rental and soil health testing. Walter and Scanlan both stated that we may want to amend the two Local Capacity Grants that have cover crop cost share set aside and reallocate those funds to BMPs or Technical & Engineering activities. The board supervisors agreed with their sentiments.
- **319 Feedlot** Scanlan stated he recently made a site visit in the targeted work area. There has not been any further discussion with the county regarding a MOA for technical assistance that was requested outside the targeted work area.
- SWAG Scanlan stated he and Messner have put together a 2020/2021 budget and work plan for the program.
- WCPI Scanlan indicated that he has been accompanying Wermager on field walkovers and is running RUSLE2 and WINPST for plans.
- Other Scanlan stated he is in the process of developing a plan for a rain garden near the proposed swine barn at the Houston County Fairgrounds.

### Jean Meiners – Program Reports

- Buffer Implementation Meiners reported there is a site along County 16 that she will be checking in the spring.
- **BMP Projects** Meiners stated that she is surveying and designing projects for 2020.
- MN Land Trust Meiners informed the board supervisors that she will be participating in a conference call on Tuesday, January 14<sup>th</sup> and it is likely that a grant agreement will be forthcoming.

### Dan Wermager – Program Reports

- WCPI Wermager stated he has performed a few site walkovers this past month and continues to make outreach phone calls.
- **Root River 1W1P** Wermager stated at their recent Policy Committee meeting it was decided to have quarterly meetings for the policy committee. This will help keep the committee more up to date.

<u>Houston County Water Plan</u> – Wermager shared that a different lab is now providing the water test kits. Project funds for 2020 will offer incentive payments for push-up ponds, pond clean outs and field borders.

• **Trees** – Messner stated she recently reduced our tree order by 800+ trees. She also stated that over the course of the past few months 500+ trees were added to the tree order to accommodate landowners' requests.

## Gary Larson, NRCS Board Conservationist Report

- Larson stated the number of CRP sign-ups are increasing. The average payment for a continuous CRP sign-up is \$149/acre and the general CRP sign-up payment rate is \$140/acre.
- Larson shared there are 55 EQIP applications in-house. This includes new and deferred EQIP and RCPP EQIP applications.
- Larson indicated that staff conducted a recent grassed waterway survey before the snow.
- Larson reported that a reply was received from the Iowa State Conservationist regarding funding for repairs to Bear Creek #3 (sinkhole). The national office approved watershed repair funds in the 2020 operating budget.
- Larson requested that a 2020 Local Work Group meeting date be set. It was agreed that this meeting will be conducted at 2 p.m. on Thursday, March 12, 2020.

# Dave Walter, SWCD District Manager Report

- Walter reported he, Scanlan, Kruse, Larson, Ressel and Rochester attended the Driftless Symposium February 4<sup>th</sup> & 5<sup>th</sup> in La Crosse, WI. Topics included MNDOT streams along state roads and streambank restorations along Trout Run Creek using various methods for stream corridor fixes.
- Walter indicated that there was conversation about Root River SWCD taking on the fiscal agent role for the Root River 1W1P. Winona County SWCD will be going to their own 1W1P. The Winona County SWCD board of supervisors have indicated that they will continue their role as the fiscal agent.
- Walter shared that we have three board supervisors that have expiring terms at the end of the year. They are Matt Feldmeier, Roger Stenhoff and Glenn Kruse.

## Program Reports:

• WCA – Walter reported the TEP committee will be holding monthly meetings on the first Tuesday of each month. The committee consists of a representative from Army Corp of Engineers, BWRS Wetland Specialist, State Hydrologist, County Highway Engineer and County Zoning Department.

Donna Rasmussen, representative of Friends of the Root River, has requested a tour of the Hokah Wetland Bank area and the US Fish & Wildlife Root River tract. This is a 600 acre tract. They are interested in a restoration of a two year flooding event of the Mississippi River.

Walter stated he visited site in Mound Prairie Township that is experiencing sluffing issues. He also worked with an individual in Brownsville Township that would like to install trout creeks.

- **Bridge Creek** Walter updated the board on the contracted waste storage facility project. The landowner discussed concerns with SWCD and NRCS staff they are experiencing with the private engineer they hired for the project. The engineering costs have dramatically exceeded the original cost estimate that was supplied by the engineer. The landowner shared with staff that concrete for the project was poured by the contractor. Staff worked with the landowner and a new agreement was reached between the private engineer and the landowner. The new cost estimate is \$45,000 and includes engineering and engineering supervision during construction of the roof.
- RCPP 1W1P Walter stated he will be reviewing applications with Larson in the near future.
- Root River 1W1P Reference District Manager's Report.
- Aquatic Invasive Species (AIS) No updates at this time.
- MAWQCP The workshop scheduled for January 14, 2020 at Good Times in Caledonia, MN was well attended. There were 50+ attendees. The workshop generated 13 new applications for the program.

### MASWCD & MACDE

Scanlan and Welke indicated that they will be attending the Legislative briefing and Day at the Capital on March 24 – 25, 2020.

A video on the two mile Trout Run Creek project in the Driftless area in SE MN (Winona, MN) was viewed.

### Watershed Updates:

**Crooked Creek** – A video of the Klinski project area was viewed by the board. Scanlan reported the NRCS state engineer and the engineering firm hired for the Kliniski project met February 10<sup>th</sup> to discuss suggested changes to the emergency spillway location, higher abutments and toe drains.

Bear Creek - Reference NRCS Board Conservationist report.

- Cooperative Weed Management Area (CWMA) Scanlan shared that one new landowner has expressed interest.
- Cover Crop Demonstration Grant Scanlan stated he has met with various implement representatives on interseeding equipment and will discuss options in the new business portion of the meeting. He also shared that he has put together policies and agreements to discuss during the new business portion of the meeting.
- 319 Feedlot Scanlan indicated from a recent mailing three producers had contacted him. Of those contacts, one has expressed interested.
- SWAG No report.
- Stream Bank Revetment Scanlan stated our application for services with the Conservation Corp of MN (CCM) has been approved. The contract is for eight days of service. The focus area is Crooked Creek.

## Jean Meiners - Staff & Program Reports

- **Buffer Implementation** Walter indicated that Meiners did a buffer mailing for spring/summer spot checks. He also shared that the State Buffer Coordinator is to be visiting our office in November to review the BuffCat program and view a few of our buffers.
- MN Land Trust Walter informed the board supervisors that an information meeting is slated for March 18, 2020. Targeted areas for this event are the South Fork of the Root River and Beaver Creek. Wermager will also be presenting on conservation planning.
- BMP Projects Walter stated that Meiners is designing grade stabilization structure projects for 2020.

## Janice Messner - Staff Report

- Trees Messner stated tree orders have been trickling in. The balsam fir are no longer available and the order form has been updated to reflect that change. She also stated that 575 trees that have been pre-ordered are currently available.
- Signature stamps Messner shared that she investigated the possibility of signature stamps being used for monthly document signing by board of supervisor officers. BWSR will not allow the stamped signature without a doctor order stating that the individual is not physically able to sign. The county attorney also advised against the signature stamp for various reasons.

## Gary Larson, NRCS Board Conservationist Report

★ Larson reported EQIP 2019 produced 41 contracts obligating \$1,034,919.00. To date \$276,903 has been paid, the remainder will likely be paid in 2020 when projects are completed. Contracted acres are 2,901.

- Larson indicated with the RCPP EQIP 2019 there were 11 contracts obligating \$200,984. To date \$31,195 has been paid with the remainder to be paid in 2020. Contracted acres totaled 152.
- Larson shared there are 46 EQIP 2020 applications in-house. Twenty-two applications totaled \$628,644 and there are 8 RCPP EQIP applications.

### Dave Walter, SWCD District Manager Report

Walter shared the Mississippi – Winona/La Crescent 1W1P will be putting in an application for watershed approval. An informational meeting will be held in April 2020. Walter stated that there are misconceptions that the JPB will then be dissolving but that is not the case. He shared only the La Crescent area is part of this watershed area not the entire county. A Houston County commissioner serving the La Crescent area as well as a Root River SWCD board supervisor representing the La Crescent area will be a part of this Policy Committee.

- Walter stated he attended a Basin Alliance Lower Mississippi Minnesota (BALMM) meeting on February 19, 2020. The federal 319 Grant for small watersheds will focus on a ten year plan for a four year grant. There was also discussion on an application for funding for the 2020 Safe Drinking Water in SE MN Private Well Users Grant that is being submitted.
- Walter reported he and Scanlan attended the From Entomology to Economics workshop on building soil health on March 5<sup>th</sup> at St. John's Church in Caledonia, MN. This was sponsored by Land Stewardship Project. Local farmers, Jordan Meyer and Connor McCormick, were on the local farmer panel. The speaker brought in entomology information and its effects on soil health.
- Walter indicated the Area 7 Envirothon will be May 6, 2020 in Byron, MN and the state competition will be May 18<sup>th</sup> at Itasca State Park, Park Rapids, MN.
- Walter shared a Conservation Tillage & No-Till Area Public Outreach meeting will be forthcoming. Scanlan, Walter and one board supervisor will be participating. No date is set at this time.

## Program Reports:

- WCA Walter reported the TEP committee met March 3<sup>rd</sup>. They visited sites and discussed the possibility of a landowner putting in trout ponds in Brownsville Twp., the installation of a bridge by the County Highway Department, in Crooked Creek Twp., and a site in Houston Twp. where a grade stabilization structure is to be installed. This project is waiting on approval from Army Corp of Engineers.
- Bridge Creek Walter stated construction on a waste storage facility has resumed. Additional cost-share slippage funds may be available to put towards this project to bring it closer to 75% cost share after an increase in the engineers fees.
- Root River 1W1P Walter reported the Policy Committee met February 24<sup>th</sup>. Fruechte, Crooked Creek Watershed Committee; Kruse, Root River SWCD Bd.; Wermager, Root River SWCD; Johnson, Houston County Commissioner and Walter, Root River SWCD were all in attendance. A few key points are: Policy Committee meetings will be held quarterly; Walter did a presentation of the proposed Klinski project in the Crooked Creek Watershed and was very well received, and it is being requested that project pictures before and after shots be taken for civil engagement purposes. This will provide the opportunity to put the project story with the photos for 1W1P.

## Watershed Updates:

*Crooked Creek* – Scanlan stated the next regular meeting is scheduled for March 20, 2020. With the Klinski project, a flat rate bid of \$10,200 was received from G-Cubed to amend the design to meet NRCS requests on the emergency spillway location, higher abutments and toe drains.

Bee & Duck Creek - No report.

**Bear Creek** – Walter stated that the Iowa state conservationist is working on the amount of funding that will be available for the repair of a sinkhole on Site #3. During conversation with the state conservationist Walter indicated that some local watershed maintenance funds were available if needed.

- **Cooperative Weed Management Area (CWMA)** Scanlan shared that some time ago he submitted an application for additional funding and will check on the status of the application.
- Cover Crop Demonstration Grant Scanlan stated the broadcast seeder has been ordered through St. Joseph Equipment. Scanlan also looked at a used no-till drill that was for sale in the county. He recommended that we do not move forward with this type of a purchase at this time. Scanlan stated that producers aren't biting on inter-seeding at this point.

Discussion followed about the possibility of purchasing a second broadcast seeder. It was decided to hold off at this time.

Scanlan stated he has been working with producers on cover crop and no-till cost sharing and have taken applications. He also shared that a few producers expressed interest in the soil health sample testing.

- **319 Feedlot** Scanlan indicated there has not been much interest in the targeted two watersheds. County Feedlot Officer Meiners indicated that it can now be made available countywide.
- SWAG Scanlan stated that the program will be ramping up in May and the SWCD will be sampling the Pine Creek.
- Stream Bank Revetment Scanlan shared Conservation Corp of MN (CCM) application was approved and are contracted for eight days of service. The focus area is Crooked Creek.

## Gary Larson, NRCS Board Conservationist Report

## Agency Reports:

### Gary Larson, NRCS Board Conservationist Report

Larson reported that he and his staff are doing site visits in conjunction with their CRP status reviews. Staff has also been writing CRP plans.

### Dave Walter, SWCD District Manager Report

Walter shared COVID-19 Reopening Phase 1 has been recently implemented. This has allowed all federal employees to return to working at the office at one time. This phase has not changed anything for SWCD staff.

- Walter stated the 2008 Ford F150 was sold for \$6,400. The new truck should be delivered later this month. The manufacture was shut down for a period of time due to COVID-19.
- Walter reported that an amendment to the FY20 Local Capacity Grant was approved by BWSR. This allowed us to take \$15,000 of Technical Engineering funds and dedicate it for CWMA cost share.
- Walter indicated with the recent rains washouts have occurred on newly installed grassed waterways. To repair the erosion a critical area planting will be implemented. Walter stated that he will be contacting Chair Kruse for cost share approval as the need arises during the upcoming month.

## Program Reports:

- WCA Walter reported there is a tiling request in the West Beaver area that he is working with and the Highway Department would like to do a bridge project in Freeburg. The area has been flagged as a wetland and the State will need to buy credits to do this bridge installation.
- **Bridge Creek** Walter stated construction is in progress on a roof structure and the manure pit portion of the project should start soon. Both projects are for the same landowner.
- Root River 1W1P Walter reported a Policy Committee meeting will be held later in June.
- SWAG Walter indicated we have one sampling site, Pine Creek. Sampling will be done three times per month.
- **RIM** Walter reported he has two site inspections left to complete. He shared that there are some conservation plan and practice changes that will need to be done as a result of this year's inspections.
- Aquatic Invasive Species (AIS) No report.
- **MAWQCP** No report.

### MASWCD & MACDE

Walter stated this year the area review meeting for the 2020 Resolution Requests will be conducted via Zoom. This allows for supervisors to participate if they are interested.

### Watershed Updates:

**Crooked Creek** – Scanlan stated they held their May meeting at the parking lot of the South Fork structure site. The June 19<sup>th</sup> meeting will also be held at this location. They will be planning the yearly Watershed structure inspection tour which will need to include an NRCS engineer. He shared there has been no status change on the Klinski project.

### Bee & Duck Creek – No report.

**Bear Creek** – Walter stated the normal inspection tour will not be held this year due to COVID-19. A group of approximately five will be conducting the inspections which include Gary Larson, NRCS and himself. The inspection reports will be sent to everyone that is typically involved in the annual tour.

Scanlan indicated that he has received an application for funding that will need to be completed for the sinkhole repair work on Site 3. The SWCD will serve as the sponsor of the project.

*Winnebago* – Walter reported that Jason Rochester, JPB, is putting together a design for a sinkhole repair on the Koch site. Walter stated maintenance funds will be used for this repair.

## Staff & Program Reports:

## **Bob Scanlan – Program Reports**

- Cover Crop Demonstration Grant Scanlan stated the broadcast seeder was requested for use. He indicated that producers are still enrolling for cover crop cost share funding.
- **319 Feedlot** Scanlan reported he is working with a landowner in Brownsville Twp. with a potential feedlot fix for a concentrated sediment area. Fifty percent cost share up to \$5,250 is available through the county.
- Local Capacity CWMA Scanlan stated he has five landowners, in addition to the application today, on a list that are interested in cost share.
- Stream Bank Revetment Scanlan shared he has been in contact with the CCM supervisor and a small crew should be here in mid-July. They will be working on a revetment site in Crooked Creek Twp. and if time allows maintenance work on the Crooked Creek Watershed structures.

# MINUTES OF THE ROOT RIVER SWCD

September 10, 2020

## Agency Reports:

## Gary Larson, NRCS Board Conservationist Report

- Larson reported that he and staff are preparing CRP conservation plans. There are approximately 154 plans with a signing deadline of September 11, 2020. They have 40 50 to complete at this time.
- Larson stated there are 44 active EQIP contracts totaling \$1.2 million. EQIP 2021 applications are starting to come in.
- Larson shared that currently construction is going on a grade stabilization structure and many are scheduled for the fall.

## Dave Walter, SWCD District Manager Report

- Walter reported several of our presenters for 6<sup>th</sup> Grade Environmental Day are unable to take part due to restrictions related to COVID 19; therefore, we have cancelled this year's event.
- Walter updated the board regarding the Lower Mississippi River Feedlot Management in MN Grant that they approved at the August 13<sup>th</sup> meeting. The sub-agreement stated the incorrect dollar amount for the number of

animal units that the project funds were ear-tagged for. The amount is substantially less. During communications with BWSR relating to the situation with the sub-agreement, he learned that the state has \$260,000 that may be allocated. A portion of these funds may come through to backfill the funding difference of the sub-agreement. Meanwhile Walter stated the current option is to use Root River 1W1P project funds to offset the difference. Further action will occur later in today's meeting regarding an amendment to the sub-agreement.

## Program Reports:

• WCA - No report.

- **Bridge Creek** Walter stated the waste storage facility is nearing completion. The ramp into the pit will be constructed next week.
- **Root River 1W1P** Walter reported the bylaw language will be changing in the near future. It will state the Policy Committee is making decisions instead of the government body.
- SWAG Walter indicated the last sampling scheduled for 2020 on the Pine Creek was conducted yesterday. All reporting will take place in October moving into November.
- Aquatic Invasive Species (AIS) No report.
- **MAWQCP** No report.
- **Building Sites** Walter shared there has recently been some building site issues in which the SWCD has been approached for input. In both cases the projects have already started. One is located in West Beaver and the other in Perkins Valley. Walter shared the circumstances of each project. Concern was voiced that the SWCD is being brought in while the projects are in progress instead of prior to the start of the projects. The projects have had to be halted in some instances.

#### MASWCD & MACDE

Messner stated that the MASWCD Annual Convention will be held virtually this year at no cost. Registration opened September 9, 2020.

#### Watershed Updates:

*Crooked Creek* – Scanlan stated a special meeting was held regarding the Klinski project. NRCS has requested additional changes to the engineer's plan on the placement of the emergency spillway. The engineering firm is not comfortable with the change being requested and has asked that NRCS sign off on technical approval of the emergency spillway. NRCS was not in favor of this and stated that they would be willing to take on the project at no cost. Having several thousands of dollars invested in the engineering and design of the project, the committee has decided to stay with the engineering firm's design and forego NRCS funding on the project. They are moving forward with obtaining the necessary permits for the project. Their next regular meeting will be held September 18, 2020.

Bee & Duck Creek – No report.

**Bear Creek** – Kruse stated that he had received an email from the state of IA about the project. Larson indicated that a previous Operation & Maintenance Agreement was requested. It is thought that they are using a prior agreement to develop the new Operation & Maintenance Agreement for the Site 3 sinkhole repair project.

*Winnebago* – Walter stated design plans have been reviewed with the landowner and were found acceptable. Board supervisors inquired about the process that will be used to repair the sinkhole. Walter also shared that county levied Winnebago Watershed maintenance funds will be used as cost share on this project. Cost share will be at 100%.

A site showing for the Site 3 sinkhole project will be held November 30<sup>th</sup> with a bid opening at noon on December 11, 2020.

#### Staff & Program Reports:

#### **Bob Scanlan - Program Reports**

• Cover Crop Demonstration Grant – Scanlan reported 1,100 acres of cover crops have been planted. One applicant has cancelled their cost share contract since they will not be the tenant in 2021. Scanlan reported that the new tenant has been contacted and would like to apply for the cover crop and no-till cost share on the 50 acres for 2021.

Scanlan shared he took soil samples and submitted to Ward Lab on ten farms. Results have been received on these locations. A second sampling will be done in 2023 to do a comparison of the soil's health after three years of cover crop and no-till.

- **319 Feedlot** Scanlan reported he is working with a couple of producers on potential feedlot fixes. Fifty percent cost share up to \$5,250 is available for each producer to address their runoff concerns.
- Local Capacity CWMA Scanlan stated he continues to work with interested landowners.

### Jean Meiners - Staff & Program Reports

• **Buffer Implementation** – Scanlan reported Meiners has been checking buffers during the past month and flagging areas where work is needed.

#### Janice Messner - Staff & Program Report

- Volunteer Nitrate Monitoring Network No report.
- Tree Program Messner shared 250 tree order forms along with a fall newsletter were mailed out. She shared we have received six orders to date totaling 15 bundles with sales at \$555.00. Messner stated she has had two inquires for special orders.
- 2021 Envirothon Messner indicated that the 2021 Envirothon will be virtual this coming year. She stated teams that are interested in participating will be taking a test and the top teams will do a video for oral presentation which will be considered the State competition. This coming year's competition will be limited to senior high teams only. Team registration deadline is December 1, 2020.

Messner informed the board that she participated in some of this year's BWSR Academy administrative sessions. The sessions were virtual and at no charge.

### Dan Wermager, Technician - Program Reports

• WCPI (Watershed Coordinator Planner Initiative) – Wermager shared that he has completed a second contact to all the landowners in the grant's targeted area. Five hundred and eleven landowners were contacted. Over the past two

weeks he reported that he contacted sixty landowners and set appointments to do walkovers with two of the landowners that he contacted. Wermager stated he has also been assisting with the CRP and EQIP work load.

• **Mississippi River – Winona/La Crescent 1W1P** – Wermager stated Winona County is the lead and we are the fiscal agent. A virtual meet and greet will be held in early December with the purpose of introducing everyone participating on the Policy Committee to each other. Welke will be representing the SWCD on the Policy Committee and Matt Feldmeier will be the alternate.

A Memorandum of Agreement was reviewed and approved by our county attorney and has been sent in.

• **Root River 1W1P** – Wermager reported on November 23<sup>rd</sup> an in person Policy Committee will be held. They will review budget and financial reporting.

<u>Houston County Water Plan</u> – Wermager shared two additional push-up ponds are going in as weather allows. One landowner recently backed out and one additional pond is scheduled to start construction in a few weeks. Wermager stated two additional pond clean outs are also slated for 2020.

<u>Minutes:</u> Motion by Welke, seconded by Graf, approving the minutes from the November 12, 2020 board meeting. Voting affirmative: Feldmeier, Graf and Welke Opposed: None Motion carried.

Treasurer's Monthly Report: Feldmeier requested that the November 2020 Treasurer's Report be placed on file for audit.

### Agency Reports:

### Gary Larson, NRCS Board Conservationist Report

- Larson reported he has 26 applications and four RCPP for 2021 EQIP. Practices include prescribed grazing, streambank restoration, forestry, wildlife habitat management, manure storage and the regular grade stabilization structures, waterways and diversions.
- Larson shared that there will likely be a CRP sign up after the first of the year.
- Larson extended a thank you to Scanlan for heading up the Bear Creek repair project.

### Dave Walter, SWCD District Manager Report <u>Program Reports:</u>

- WCA Walter reported he was alerted about a concern in Brownsville Township. After visiting the site he found no violation.
- Bridge Creek Walter stated the fence on the manure waste storage facility was all that remained to complete this project.
- Root River 1W1P Walter share that a Policy Committee meeting was held on November 23, 2020. During this meeting, it was decided that the Policy Committee should review projects instead of giving final approval to pay on

invoiced projects. This will allow the grant's financial representative to pay invoiced projects when the invoice is received instead of waiting until a Policy Committee meeting.

- Aquatic Invasive Species (AIS) No report.
- MAWQCP Walter reported a few applications are in that will be worked on next month.
- **BMP Projects** Walter stated the manure storage facility in Mayville Township is complete. He indicated that there were overruns on the project and they have been justified by the TSA sub-contractor.

A waste facility cover in Crooked Creek Township is underway. The concrete for the project is poured.

A grade stabilization structure was installed in Black Hammer Township and a rock shoot project in Sheldon Township is being constructed.

## MASWCD

Kruse and Welke shared they participated in the MASWCD 2020 Annual Convention on December 8, 2020. A new president and vice president were elected and resolutions approved.

#### Watershed Updates:

Crooked Creek - Scanlan stated their December meeting will be held at the Freeburg School.

Bee & Duck Creek - No report.

Bear Creek - Scanlan reported the bid opening for the sinkhole repair project will be held Friday, December 11<sup>th</sup> at noon.

*Winnebago* – Walter reported that the landowner met with the contractor on a sinkhole project located on one of the Winnebago Watershed project sites. Construction is scheduled to begin on Monday, December 14, 2020.

## Staff & Program Reports:

**Bob Scanlan – Program Reports** 

- Cover Crop Demonstration Grant Scanlan reported with the mild weather he is seeing some of the cover crops that were planted are starting to green up.
- 319 Feedlot Scanlan reported a feedlot fix project in Brownsville Township has been completed.
- Local Capacity CWMA Scanlan stated a project in Union Township was finished.
- Conservationist of the Year Scanlan suggested since we are unable to hold an honorary recognition this year that perhaps we offer the recipient a monetary gift. The board suggested that we wait till spring to see if a recognition event could be held then.

Scanlan stated that he and Wermager attended the Soil Health Summit. He also informed the board a producer in Crooked Creek Township has applied for the MN Department of Ag No-Till Grant and was asked to provide assistance as needed with forage measuring and soil sampling. Scanlan shared that he has submitted a grant application for the CCM crew for 2021. He explained that the streambank revetment work has not had any recent requests, so he applied for maintenance assistance on the Crooked Creek Watershed structures.

Scanlan shared that he has also been working on a prescribed grazing project.

#### Jean Meiners – Staff & Program Reports

**Buffer Implementation** – Walter reported Meiners is working with a landowner in Yucatan Township to re-establish a buffer.

Walter stated that Meiners has also been doing survey and design work.

#### Janice Messner - Staff & Program Report

- Volunteer Nitrate Monitoring Network No report.
- Tree Program Messner shared that 20 tree orders have been received, consisting of the sale of 1,600 trees.

#### MACDE

Messner share she participated in the MACDE meeting held December 8, 2020. She stated Kyle Weiman of Stearns SWCD was named Outstanding Employee. She shared that many of the areas in the state were reporting an increase in landowner inquires regarding resource concerns.

Messner informed the board that she participated in a free Zoom training offered by University of MN and MASWCD.

#### Dan Wermager, Technician - Program Reports

- WCPI (Watershed Coordinator Planner Initiative) Wermager shared that the outreach goal has been completed for the grant and walk overs have declined. He indicated a new priority area has been designated and focuses on the Riceford project area.
- Mississippi River Winona/La Crescent 1W1P Wermager stated a Policy Committee meeting will be held virtually on December 14, 2020.
- **Root River 1W1P** Wermager shared during the Policy Committee meeting they added two BMPs for 1W1P. The BMPs are Pre-Construction Cover and Prairie Stripping.

Wermager shared that he participated in a silvopasture webinar. He stated that silvopasture is a new NRCS BMP practice focusing on pasturing within trees. Wermager reported that he has been providing EQIP application assistance to the NRCS staff, checking design plans and helped lay some contour strips.

<u>Houston County Water Plan</u> – Wermager shared that 2020 project installation went well. Ten push-up ponds were planned. Seven are completed with an additional one near completion. Six pond clean outs were planned and four were completed. He stated the committee talked about changing their meetings to every other month.
