# **REQUEST**

A Conditional Use Permit for a cabin is requested.


#### SUMMARY OF NOTEWORTHY TOPICS

The applicants, Joseph and Laurie Bolduan, are requesting to place a cabin on the Northeast edge of their field on parcel no. 14.0286.000. The red X on the map below shows the proposed location of this cabin. The cabin is 20' wide by 20' long and will have a 4' porch on the East side. The second map below depicts slope percentage. Red indicates a slope greater than 24%, which is too steep to build on according to Houston County Ordinance chapters 3.6 subd. 2 and 25.2 subd. 4. The proposed cabin would be placed on level ground and will be more than 40' from the top of the bluff. Houston County Zoning Ordinance chapter 29.17 Subd. 2 states that structures shall be set back at least 40' from the top of a bluff.

Cabins are subject to the following:

- (a) Not more than one (1) cabin per quarter of a quarter section shall be allowed.
- (b) A cabin shall not have a permanent foundation or basement, or otherwise be permanently attached to the ground.
- (c) A cabin shall be for transient use only and shall not be used as a permanent, year-around dwelling.
- (d) No cabin shall have a gross floor area exceeding 400 square feet.
- (e) Cabins shall not be connected to modern utilities, including electricity, telephone service, and septic.

A 384 s.f. cabin footprint is proposed. The cabin would have a loft and a deck (in addition to 384 s.f.). The cabin would be placed on piers.



#### TOWNSHIP AND NEIGHBORHOOD COMMENTS

Neighboring property owners and Union Township were notified of this application and two comments were received.

### SITE CHARACTERISTICS

The subject parcel is 80 acres and is connected to two, 40 acre parcels owned by the applicants. The parcel consists of a field, meadow, and wooded acreage. With the proposed cabin location being on top of the bluff, the building envelope is over 95 acres. The soil of the proposed cabin location is a Blackhammer-Southridge silt loam. There is some tendency for this soil to shrink and swell but those soil characteristics can easily be mitigated by adding some sand next to any new foundation. This cabin would be built on piers so this would not be a problem at all.

# **SUMMARY OF NOTEWORTHY TOPICS**

The Applicant is requesting to place a cabin on the Southeast corner of his property. The cabin is 12' wide by 32' long, it is outside of the road setback, and it is greater than 50' from the applicant's property lines. The cabin will replace an RV that was recently removed from the same location (Figure 1).

Cabins are subject to the following:

- (a) Not more than one (1) cabin per quarter of a quarter section shall be allowed.

# TOWNSHIP AND NEIGHBORHOOD COMMENTS

# SITE CHARACTERISTICS

The subject parcel is approximately 80 acres consisting of woodland and meadow, the majority of the terrain is steep. The proposed building locations offers a half acre envelope laid in steep slopes that could be connected to a larger 3+ acres envelope to the northwest. Soils are a Kennebec silt loam. The Soil Survey indicates flooding hazard is commonly a limitation for building on this soil type, however, floodplain is only found on the south side of County 4 in this location. There are no mapped water features or wetlands near the proposed location.

The cabin is proposed at the foot of a saddle that runs from the base of a bluff to the valley floor, however, as the elevation change is less than 50', it was determined not to be a bluff, thus no toe setback is required (Figure 2 & 3). Further to the west, a bluff rises 280+ feet at slopes exceeding 40%.

The Decision Band Method is the system the County uses for its formal job evaluation process. This methodology is accepted by the State of Minnesota as a valid classification process for the purpose of the County's mandated comparative worth analysis and reporting. The primary criteria for evaluation of the job duties are based on decision-making, supervision, complexity and difficulty of job responsibilities. Additionally, job value hierarchy and internal equity are also critical elements when reviewing individual jobs and the county's job classification structure. Internal department job comparisons were done for positions as well as comparisons of positions across other departments in the County for the purpose of job and pay equity.

The following jobs require banding adjustments. It is recommended that incumbent employees with upward pay increases be effective to August 2, 2020. Reporting directly to the County DOT Engineer and taking direction from the Highway Maintenance Foreman, the Highway Maintenance Specialist (HMS) performs a variety of road construction and bridge maintenance. The HMS operates bulldozers, motor graders, backhoes, front-end loaders, skid steer loaders, industrial tractors with mowers, sand pull and screen plant, rubber-tired roller, powered broom, and shoulder disc.

**Position: Agency Case Aide** 

This position is currently rated B22.

Under the general supervision of the Financial Assistance Supervisor this positon is responsible for performing a variety of tasks related to the delivery of services by agency child support officers. Primary responsibilities include acting as front line contact, and assisting Child Support Officers gather client information.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Child Support Case Aide** 

This position is currently rated B22.

Under the general supervision of a unit supervisor this position is responsible for performing a variety of para-professional and office support tasks related to the delivery of services by agency social workers, eligibility workers, and nurse-case managers.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Child Support Officer** 

This position is currently rated B24.

Under the general supervision of the Financial Services Supervisor, this position in collaboration with the County Attorney's Office establishes paternity, enforces child support orders, and locates absent parents.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

The position performs responsibilities that require decisions about "how" and "when" to perform specified processes. The overall process is defined through operational policies, and this position must operate with these set limits.

The classification receives a subgrade of four (4), because of the high complexity and diversity of tasks in the B2 band and grade compared to other B2 rated positions. Thus, we recommend the evaluation of the position remain at the B24 level.



Position: Eligibility Worker

This position is currently rated B23.

Under the general supervision of the Financial Assistance Director, this position determines the eligibility of applicants and on-going recipients of public assistance programs; communicates program requirements; supports program participants in achieving self-sufficiency; identifies needs and makes referrals to a variety of community resources.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Financial Assistance Division Supervisor** 

This position is currently rated C42.

Reporting to the Public Health & Human Services (PHHS) Director this position administers the County's Income Maintenance and Child Support units. The position ensures that state and federal regulations and guidelines for Income Maintenance/Child Support are met and maintained; and established and assesses divisional goals.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Accounting Technician**

Reporting to the Public Health and Human Services (PHHS) this position is responsible for maintaining and balancing accounts; providing technical assistance; preparing required reports and schedules; compiling financial data; and assisting with budget planning and analysis; and audits.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Collections Officer** 

This position is currently rated B23.

Under the general direction of the Public Health and Human Services (PHHS) Fiscal Supervisor, this positon determines and collects funds owed to the county.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Fiscal Services Supervisor** 

This position is currently rated C41.

Reporting to the Public Health & Human Services (PHHS) Director, this position oversees financial transactions; develops and maintains agency financial records; supervises the fiscal unit staff; initiates the preparation of the agency budget and individual program budgets; oversees the preparation of multiple fiscal/statistical reports, and develops and maintains internal controls for various audits.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

Reporting to the Social Services Supervisor or Public Health Supervisor, this position provides direct client services in social work areas and provides work direction to paraprofessional staff.

**Position: Social Worker- Child Protections** 

This position is currently rated C41.

Reporting to the Social Services Supervisor or Public Health Supervisor, this position provides intensive social work services for the protection, rehabilitation, and care of children for both voluntary and non-voluntary child protective service cases; and provides work direction to paraprofessional staff.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Social Work Lead** 

This position is currently rated C42.

Reporting to the Social Services Supervisor (SSS) this position provides direct client services in social work areas; assigns work; directs, guides and trains to social workers and case aides; ensures quality control for assigned programs; and assists the SSS in monitoring program compliance and in the evaluation of social workers/case aides.

We have examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Social Services Supervisor** 

This position is currently rated C52.

Reporting to the Public Health and Human Services (PHHS) Director, this position is responsible for the administration of County's Social Services programming. Responsibilities include managing intake, child protective services, adult protective services, mental health case management, chemical dependency, commitments, guardianship/ conservatorship, foster care, and day care licensing. The position is also responsible for setting departmental goals, developing a plan to achieve those goals, and assessing outcomes.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

The classification receives a subgrade of two (2), because of the high complexity and diversity of C5 tasks in relation to jobs in the same band. Thus, we recommend evaluation of the position remain at C52.



Position: Public Health and Human Services Director

This position is currently rated at D62.

Reporting to the County Administrator, the Public Health & Human Services Director is responsible for the administration of County agency programs and services and provides leadership to all County PHHS units. Responsibilities include delivery of agency services and fiscal oversight of PHHS service sectors of Children's Services, Adult Services, Public Health, Financial Assistance, and Fiscal operations. This position provides direct supervision of the Department supervisory staff.

Gallagher has examined the essential duties of this position and has evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

**Position: Health Educator** 

This position is currently rated C42.

Reporting to the Public Health Supervisor, this position is responsible for the development and implementation of health education programs for the County. The Health Educator develops, promotes, and delivers health education that addresses local priorities developed through the community health assessment and community health improvement planning process.

**Position: Public Health Nurse** 

This position is currently rated C42.

Under the general supervision of the Public Health Supervisor, this position is responsible (PHN) is responsible for providing the full range of essential public health services in collaboration with the Public Health team to promote healthy communities and individual behavior.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:

Position: Nurse - Case Manager (RN)

This position is currently rated C41.

Reporting to the Public Health Supervisor, a Nurse-Case Manager provides Home and Community Based Services (HCBS) and promotes public health by providing public health nursing, casement management for adults and children.

Position: Public Health Supervisor

This position is currently rated C52.

Reporting to the Public Health and Human Services (PHHS) Director, this position is responsible for the administration of the County's Public Health programming. Responsibilities include administering federal and state programs; family health, environmental health, communicable diseases, health promotion, long term care, Waiver programs, and public health emergency preparedness. The position is also responsible for setting departmental goals, developing a plan to achieve those goals, and assessing outcomes.

Gallagher has examined the essential duties of this position and have evaluated the position using the Decision Band Method® (DBM). The job evaluation shows the following:
