File No. 3 – Prior to any motions being made Commissioners discussed a resolution for establishing school zone speed limits in La Crescent. Commissioner Schuldt said the way the resolution read the speed limit would be 20 mph when children were present. He said the areas were frequented by families, so the speed limit of 20 mph could be enforced outside of school hours if children were present. He said enforcement would be at officer discretion. Commissioner Schuldt said the City of La Crescent was considering a 25 mph speed limit City wide at one time. He asked if this was still being considered and if it would be easier to understand if the speed limit was 25 mph at all times. Commissioner Severson said the City was no longer looking into a 25 mph speed limit City wide. Severson agreed the speed limit could be enforced at each officer's discretion if children were present. Commissioner Severson moved, Commissioner Schuldt seconded, motion unanimously carried to adopt adopting Resolution No. 24-12 Establishment of School Zone Speed Limit. See resolution below.

## **RESOLUTION 24-12**

# **Establishment of School Zone Speed Limit**

May 21, 2024

WHEREAS, there are schools located along <u>Houston County</u> highways within the City of La Crescent; and

WHEREAS, <u>Houston County</u> may establish school zone speed limits in accordance with MN Statutes 169.14, Subd. 5a; and

WHEREAS, a review of the school zone route has been conducted; and

WHEREAS, recommendations for establishing school zone speed limits were made;

NOW THEREFORE, be it resolved that <u>Houston County</u> does hereby agree to the establishment of school zone speed limit postings of "20mph When Children Are Present" at the following locations are hereby approved:

- $\Box$  On Houston County State Aid Highway 6 from the alley between S 4<sup>th</sup> St and S 3<sup>rd</sup> St to the alley between & S 6<sup>th</sup> St and S 7<sup>th</sup> St approximately 1,079 feet.
- ☐ On Houston County State Aid Highway 29 from the alley between S 1<sup>st</sup> St & Main Street to the alley between S 2<sup>nd</sup> St and S 3<sup>rd</sup> St, approximately 719 feet.

The County Engineer shall arrange for installation of said signage.

This resolution shall be in full force and effect upon installation of said signage.

File No. 4 – Commissioner Burns moved, Commissioner Severson seconded, motion unanimously carried to approve a contract with Ciel Strategic Innovations to conduct a strategic planning process for our Public Health Division. Public Health and Human Services Director Pugleasa said the legislature had approved historic increases in long term funding for Public Health the prior year. The strategic planning process would allow the County to integrate the new funds and associated responsibilities to best serve Houston County residents. The contract fees would be covered with grant funds and would not add to the budget.

File No. 5 – Prior to any motions being made the Commissioners discussed with Human Resources Director Kruger a banding and pay rate change for the County Assessor, Kruger recommended a change to D61, Step 9. Kruger said Assessor Office employees in Houston County were being recruited and looked at by other Counties. This led to questions around if staff were being paid appropriately. David Drown Associates DDA (a third party) had looked at banding and determined the Assessor's banding should change from a C53 to D61. Kruger said currently the Houston County Assessor was making \$87,000 per year while comparable counties were paying around \$30,000 more for the position than Houston County. Kruger said the proposed change would put the Houston County Assessor at \$106,000. Commissioner Schuldt asked why the banding was so far off, and when banding was looked at. He asked if the County reviewed banding on a schedule. Kruger said a compensation study had been done in 2021-2022. She said at that time several positions were re-banded. Kruger said department heads could look at banding annually. Commissioner Severson said the Assessor's Office was doing a great job. He said it was difficult to keep good people and sometimes the County needed to adjust. Kruger said it was important to separate market concerns from decisions as to the correct band. Commissioner Severson moved to approve the banding and pay rate change of Lucas Onstad. Assessor to D61, Step 9 effective 05/27/2024. The motion failed for lack of a second. The discussion continued and Commissioner Burns asked what the likelihood would be of ramifications if the County changed the Asessor's step. Commissioner Myhre asked what the union would think of the change, and said he thought other departments would also request changes if the County made the change. Commissioner Severson moved, Commissioner Burns

seconded, motion carried to approve a banding and pay rate change of Lucas Onstad, Assessor to D61, Step 7 effective 05/27/2024. The Commissioners voted by roll. Commissioners Severson, Burns, and Schuldt voted yes. Commissioner Johnson abstained due to a conflict of interest. Commissioner Myhre voted no.

File No. 6 – Commissioner Myhre moved, Commissioner Severson seconded, motion unanimously carried to approve an EDA loan request from Bryan Spier and Tracey Knutson in the amount of \$30,000 for a market/deli business called Frank and Julia's to be located at 138 S. Kingston Street in Caledonia at the 2024 set rate and terms of 3.5% for ten years.

File No. 7 – Commissioner Myhre moved, Commissioner Burns seconded, motion unanimously carried to allocate ARPA funds for Splunk, server, RSA, and Boardroom technology in the amount of \$101,251.00. IT Director Milde said the technology in the boardroom would be updated. He said Splunk was a logging tool that was needed as the FBI had passed on new rules to the BCA. He said Splunk would monitor County logs and look for anomalies. The BCA and other counties in the region would be using the same program. Milde said a server update was needed to be able to operate Splunk. Milde said RSA would also be needed in October. RSA was a multifactor identifier. Milde said the new programs would come with unavoidable costs to the County in the future as the updates were required.

File No. 9 and 10 — Commissioners discussed a banding and pay rate change of Administrative Legal Assistant Cindy Augedahl and Administrative Legal Assistant Julie Von Arx-Abnet from B23 non-exempt to B24 non-exempt, Step 7 effective 05/06/2024 with Human Resources Director Kruger. Kruger said job descriptions had been sent to DDA and DDA had made the recommendation to change from B23 to B24. Commissioner Johnson said he did not agree with the banding suggested by DDA, and said there had been back and forth discussion on the job descriptions. Kruger said she believed the job descriptions were clear and concise, however she said she could arrange for a meeting so the administrative legal assistants could talk directly with DDA. It was the general consensus of the Commissioners that Kruger should arrange a meeting for the assistants to speak directly with DDA. The matter was tabled and would be revisited after the meeting with DDA.

Commissioners discussed recent and upcoming meetings including a Root River Watershed One, Workforce Development Inc., Opioid Settlement, Childcare Core Team, and Hiawatha Valley Mental Health Meeting.

Commissioner Johnson said he wanted to clarify some information the paper had printed regarding the investigation relating to a public comment made at the September 26, 2023 Board of Commissioner Meeting. Johnson said it was outside council that had made a determination that nothing had been done wrong, but it was determined that the process was confusing and very unorganized. Johnson said he hoped in the future the County could come up with a Code of Conduct to prevent confusion from happening again. He said he had yet to see a new hiring policy that had been worked on. Myhre said he too had not seen the policy and he said it had been worked on for a long time.

There being no further business at 10:54 a.m., a motion was made by Commissioner Myhre, seconded by Commissioner Severson, motion unanimously carried to adjourn the meeting. The next meeting would be a regular meeting on May 28, 2024.

Thank you for your continued support of Semcac's programs in Houston County. With your help, Semcac continues to advance its mission to empower and advocate for people to enhance their self-sufficiency by maximizing community resources.

Our most-recent independent audit report, IRS Form 990, and Annual Report are found at semcac.org/fiscal-documents-info. As a Community Action Agency, Semcac qualifies for county funding under *Minnesota Statute 375.18*, *Subd. 15*. The following programs are requesting funding to sustain services in 2025:

Senior Nutrition	\$2,500
Senior & Caregiver Advocacy Program	\$3,500
Volunteer Driver Program – senior donation rides	\$1,500
Houston County Food Shelf in Caledonia	\$1,500
Rolling Hills Transit – public bussing	\$5,000

## **Senior Nutrition**

In 2023, **25,627** prepared, nutritious meals were delivered to 286 seniors in Houston County, in the communities of Caledonia, Eitzen, Hokah, Houston, La Crescent and Spring Grove. The need for Semcac's Meals on Wheels home-delivered meal service is especially evident in Houston County. In 2023, **12,240** hot, nutritious, Registered Dietitian-approved meals were served in a congregate setting to 208 seniors age 60+ and their spouses in Houston County. The Senior Nutrition Program helps low-income, homebound, and/or nutritionally at-risk seniors. There are no income eligibility requirements, and no one is denied a meal. For most participants, this is the main meal of their day. Senior Nutrition is requesting **\$2,500** to support these services in Houston County.

## **Senior & Caregiver Advocacy Program**

The Senior & Caregiver Advocacy Program works closely with seniors and their caregivers to identify needs, access resources, make informed decisions and reduce feelings of isolation. The advocate is trained in the State health insurance programs (as MNsure Assistants) and are knowledgeable about Medicare options—helping clients navigate the health insurance and healthcare systems. In 2023, **44 seniors and caregivers** received assistance from Semcac's Caregiver Advocate in Houston County. In addition to working one-on-one with clients, the advocate participates in community events to

present information about other programs or issues of interest to seniors. The Senior & Caregiver Advocacy Program is requesting \$3,500 from Houston County.

# **Volunteer Driver Program**

In 2023, the Volunteer Driver Program coordinated volunteer drivers to provide **798 rides for 63 seniors** in Houston County. These rides help seniors maintain their independence, attend medical appointments, and meet their personal needs. The program also provides rides for Medical Assistance recipients and other county clients under contract with the Department of Human Services. The **\$1,500** requested will help support the donation-based rides for Houston County senior citizens.

## **Rolling Hills Transit – Public Bussing**

Rolling Hills Transit is available for everyone. In 2023, 4,900 rides were provided for Houston County residents. Brownsville, Hokah, Caledonia, Houston and La Crescent have service Monday-Friday, 7a-5p. Riders utilizing this service are children going to and from preschool and daycare and seniors, individuals with disabilities, or low-income individuals who need transportation for appointments, work, or shopping at local businesses. The MN Department of Transportation currently supports up to 95% of the operating budget, but a local match is required and can be up to 20% (which was the case prior to COVID-19). MnDOT also supports infrastructure costs, with a local match up to 20%. One of the Caledonia buses was replaced this year at 20% local match, amounting to nearly \$28,000 to replace the bus. We were able to secure a Gundersen grant to cover a portion of the cost, but program reserves were also used. A second Caledonia bus needs replacement at the end of this year if match dollars can be secured. We are requesting \$5,000 to help with the required local match.

# **Houston County Food Shelf**

Semcac's Houston County Food Shelf, located in Caledonia, provides individuals and families in Houston County with a variety of foods and the opportunity to expand limited household budgets to meet other basic needs. To use the food shelf, the household income needs to be at or below 300% of the Federal Poverty Level. (Emergency food is available to any household experiencing a food crisis.) In 2023, the Houston County Food Shelf provided food to **624 people in 250 households**. These households made 1,336 visits to this food shelf. Donations are accepted on an ongoing basis. The Houston County Food Shelf is requesting **\$1,500**.

Semcac representatives will be attending the May 28, 2024 Houston County Board meeting to share program information and agency updates. We look forward to continuing our important partnership with Houston County!

# Semcac's Impact in Houston County, 2024

Senior Nutrition results in seniors who are empowered to maintain their health and nutritional wellbeing and allows at-risk seniors to remain in their own home.

- 12,240 hot, nutritious meals were served in a congregate setting at Senior Dining to 208 seniors age 60+ & spouses, in Houston County. A Registered Dietitian approves meals.
- 25,627 nutritious meals were delivered to 286 seniors by Meals on Wheels volunteers to Houston County seniors in Caledonia, Eitzen, Hokah, Houston, La Crescent and Spring Grove.

Senior and Caregiver Advocacy results in seniors maintaining safe and independent living.

 44 seniors and/or caregivers in Houston County received individual assistance to identify needs, access resources, make informed decisions and reduce feelings of isolation.

Energy Assistance results in keeping people warm by heating homes during the winter season, thus extending the limited, low household income.

• 396 households in Houston County received assistance with their utility payments during the winter season. And, 96 households received additional crisis assistance.

Weatherization results in greener communities, lower energy bills for low-income people and creates new jobs.

- 11 households in Houston County had their homes weatherized and learned more about energy conservation. 14 households received home conservation services funded through the local utility companies' Conservation Improvement Programs, in Houston County.
  - o 3 households received energy related repairs, such as furnace replacement.

Housing Rehab Loans result in improved living condition for low-income people and the preservation of quality affordable housing.

- In Houston County, 1 homeowner received assistance via Semcac Housing staff utilizing the Minnesota Housing Owner Rehab Loan Program and the MN Housing Fix-Up Fund Loan Program.
- 10 households received assistance via Small Cities Development Program funding for homeowners in the City of Hokah. (In partnership w/ CEDA, who will help with commercial & rental rehabs.)

Head Start & Early Head Start result in empowered families and young children who are ready for kindergarten. Head Start families receive comprehensive services from Semcac.

- 18 individuals (10 children and their families) were educated at the Head Start Center, in Houston County during the program year.
- 3 children (age birth 3 years) and/or pregnant women received Early Head Start services, at their home, in Houston County.

Outreach and Emergency Services supports people through a crisis and allows them to utilize their limited income until they reach stability.

• **250** households (624 people) accessed food for their families and extended their limited incomes by visiting the Houston County Food Shelf located in Caledonia. These households visited more than once; we provided food shelf assistance **1,336** times.



- 71 individuals received crisis financial assistance for transportation, a medical issue, utility payment assistance or another immediate basic need.
- 48 individuals were assisted with payments such as rent or mortgage, provided with motel vouchers, or assisted to prevent homelessness in Houston County.
- Outreach & Emergency Services staff provided information & referrals to other/outside organizations for 803 individuals from 309 families in Houston County. Staff also provided information & referrals within the agency to 448 households in Houston County.

Semcac Clinic (located in Winona) services result in an increased number of cancer screenings for women, prevention & treatment of STI's, a reduced number of unplanned pregnancies, an increase in education about sexual health.

 12 patients permanently residing in Houston County were provided services at Semcac Clinic in Winona. In 2023, Semcac Clinic provided 788 patients with contraceptives and 366 STI/STD screenings. Also, Clinic staff presented comprehensive, reproductive and sexual health education information at events in the community.

Semcac Transportation results in people getting to their medical and dental appointments, senior dining and other locations to meet essential needs; assisting people with no other means of transportation.

- 4,900 rides were provided on Rolling Hills Transit buses in Houston County.
- 798 rides were provided to 63 seniors through the Volunteer Driver Program in Houston County.





# PASSENGER RIGHTS

- Riders are entitled to a safe, cost-effective ride, with a competent driver.
- Any information given to dispatch regarding your ride will be kept confidential.
- The bus is available to everyone for any reason. Individuals of all ages may ride the transit bus to go to places such as the grocery store, medical clinic, pharmacy, hair salon, ilbrary, etc. All transit buses are equipped with wheelchair lifts that are accessible to all individuals.
- In accordance with Title VI of the Civil Rights Act Rolling Hills Transit will not discriminate against any individual, regardless of race, color or national origin.



# PASSENGER RESPONSIBILITIES

- dispatch at 507-634-4340 or 1-800-528-7622 Monday-Friday between the hours of 8:00am and 4:30pm to schedule your ride. Rides may only be scheduled through dispatch and are scheduled on a first come first serve basis.
- Separate rides need to be scheduled for each leg of your trip. Passengers shall schedule all return rides with outbound rides when setting up trip.
- The bus may arrive up to 10 minutes before or 10 minutes after scheduled pickup time. This is known as the "pickup window" and is necessary for the transit system to operate effectively. The rider shall be prepared and ready to go when the driver arrives.
- The driver shall not wait longer than 5 minutes past scheduled pick up time for any client.
- Passengers should be prepared to pay at the time service is provided unless other arrangements have been previously made with RHT management or dispatch.
- Exact amount of change, check, or pass value is required at time of ride. Drivers do not carry change.
- A passenger's trip shall not be altered by the driver once they have boarded the vehicle. Any changes to the trip would need to be made prior to the

trip by the dispatch office based on availability or a future ride would need to be scheduled.

- Riders are required to fasten their seatbelt while the bus is in motion.
- Passengers transporting a child and opting for the use of a child restraint device (car seat, booster seat) must properly install the device and meet standards adopted by the U.S. Department of Transportation. RHT does not provide these devices; the parent or legal guardian must provide the child restraint device.
- Number of packages shall be limited to what a passenger can carry on board in a single trip. Drivers shall not assist with getting packages or parcels from the vehicle beyond curbside drop off point.
- Bags and packages must remain with the passenger and may not obstruct the aisle or the wheelchair securement area.
- In Minnesota, we can experience bad weather such as flooding, ice, and snowstorms. Our service area includes many rural roads. RHT makes every attempt to safeguard our passengers, drivers, and employees who may be at risk by traveling across any unsafe road in bad weather. If a driver feels a particular trip is unsafe he/she must notify dispatch for a final

- determination so that RHT dispatch may notify the rider(s) affected by the cancellation. In this case it is the rider's responsibility to prepare alternate transportation or reschedule the trip.
- Passengers are to be courteous, considerate and respectful of their fellow passengers, driver, and bus. Passengers who are disruptive or unsafe may be asked to leave the bus.
- No foul language, fighting, harassment, intimidation or horseplay will be tolerated.
- Eating, drinking, tobacco, and drug use are not permitted on the buses.
- When a customer does not properly cancel his/her ride they will be charged for the ride.
- Reminder: All rides/changes must be made through dispatch and not with drivers.


